Dear Parents and Carers

Free School Meals + Residential Costs

This week we have been handing out £30 vouchers to all our children who are eligible for free school meals (FSM) to cover the costs of dinners over the fortnight holiday. This is all funded by the Local Authority. Did you know that as well as being able to have free school meals and vouchers, if you are entitled to FSM then you are also entitled to a much-reduced cost for any school residentials! Next year we will have 5 year groups who will have the option to attend a residential. Dinner Money

Speaking of dinners, can I just request that any owed dinner money is paid to school as soon as possible. School doesn't provide children's meals directly. We use a catering company supplied by Edsential. So money owed is money owed to Edsential – not to school. If dinners are unpaid then school has to use money that is meant for the children's education to settle the bills – and school budgets are really tight at the moment! As we have reached the end of the financial year, we are trying to collect all owed money as soon as possible so we can close the financial books for 2024/25. If you have any difficulty with paying debts of any sort, please do contact school so that we can work together to find a solution.

Special Needs Co-ordinator (SENDCo)

As you probably know, our wonderful SENDCo Mrs Higginson will be taking a break from Elton Primary School for a while starting from Easter as she looks forward to some quality time with her new arrival! During her maternity leave, Mrs Harland will become our SENDCo and so will take charge of all areas related to special needs.

I have already informed Yr3 and Yr5 parents that Mrs Higginson's teaching commitment will be taken over by Mrs Harland and Miss Curry temporarily increasing the number of days they work with us.

Attendance - lates, holidays and illnesses

Attendance continues to be a hot topic of conversation for schools nationally and some parents have asked for clarification recently so I thought I'd just recap key points here. Remember Mrs Deakin, Mrs Henderson and I are all here to support you with any attendance difficulties you have – do speak to us on the playground or phone school if there's any way we can help.

LATES – The school takes the register at 8:45am and at 1:00pm. If a child is not in their classroom at those times, then they are recorded as late. We do try to lock gates at 8:45 but this isn't always possible as we'd often be trapping parents in school for the day!

If a child arrives after 9:15 then they are classed as having been absent for the whole morning session and will receive an **unauthorised absence** for that morning session.













Artsmark Silver Award Awarded by Arts Council England **HOLIDAYS** – School is not allowed to authorise an absence for a holiday under any circumstance any more. A holiday must be coded as an **unauthorised absence**.

If a child has 10 sessions over 10 school weeks in which they have been absent and the absence hasn't been authorised they can face a fine (each day has two sessions – 8:45 and 1:00 registration times). The government rules state that if the 10 unauthorised absences have been due to a holiday then this must result in a school fining the parents.

So for example, if a child took 2 days holiday this week and 3 days holiday any time within the next 10 school weeks (which doesn't include school holiday weeks) then school HAS to issue a fixed penalty notice (FPN) of £160 per parent per child. So, a family of two parents with 2 children would face a fine of £640. This would be reduced to £320 if paid in 3 weeks, but only if it was the first offence.

Please note the school doesn't get the money! Our duty is to report attendance to the Local Authority who then issue and collect FPNs.

ILLNESSES – An illness is classed as an **authorised** absence so would never lead to a fine. However, if a parent doesn't phone in to explain the absence, **then it remains unauthorised** and so can lead to fines. This is why it is essential that parents contact school to tell us why a child is absent. If a child has 15 days or more of illness in one school year then school has to notify the Local Authority (LA). This is because the LA has a statutory duty to support children who have additional medical needs. The government use 15 illness days as the indicator that a child may have additional medical needs. If, however, a child was only off for reasons like chickenpox etc. then the LA would not need to offer any further support.

The 15 days includes all days in the academic year – so it could, for example, be a child having 15 separate days off over the year or a block of 3 weeks absence following an operation. The rule has been brought in to just ensure the LA can meet its statutory duty of offering support when needed. We have started to notify the Local Authority about some of our children meeting this threshold. I will stress again that illnesses are **authorised** and so would never lead to a fine. What can happen at times is that the school is advised to seek medical evidence if illness absences become very frequent.

Wraparound Provision

Just a quick reminder that school does host "Wraparound Provision" on our site each day from 7:30-8:30 and 3:15-6:00. The provision is run by a separate organisation called "LBC Kids Elton" who are OFTSED registered. Miss Price is the best person to speak to as she is connected to both school and LBC Kids. You can also collect leaflets, registration forms and price lists from the school office.

That just leaves me to wish everyone a great Easter break and remind you all that school closes at the normal time of 3:15 this Friday and then re-opens on Wednesday 23rd April.
